# 1. WHAT WE REQUIRE.

Evolution Lifts & Escalators and its employees are committed to protecting your privacy and personal data. Our Personal Data Protection Policy governs the use and storage of your data. By using our website, you are agreeing to be bound by this Policy.

When you submit such a request or electronically pass information to Evolution Lifts & Escalators we will receive this information via email to one or more of the following; to our website, to our general enquiries inbox (info@evolutionlifts.ie) or to an individual employee's inbox. From this we will collect your email address and any other information which you provide, such as name, job title, contact telephone number(s) and any information contained within your email signature.

# 2. HOW DOES EVOLUTION LIFTS & ESCALATORS USE THE PERSONAL INFORMATION IT COLLECTS?

For Evolution Lifts & Escalators to deal with any enquiry or request which we receive from you and for maintaining records of correspondence.

In line with fulfilling our obligations under respective contracts, including sending you order receipts, order confirmations and to arrange the delivery of the goods you have purchased.

When we receive an order and complete associated works, we have a legal obligation to issue you an invoice for the works completed and goods you have purchased from us. When we receive an email via our web form, we collect certain pieces of information including your name, email address and any other information which you provide within your message.

Evolution Lifts & Escalators may also use the information it gathers to communicate with you regarding new products or services offered by Evolution Lifts & Escalators or to notify you of any safety concerns.

When we receive a telephone call from you, we may collect your name, contact telephone number(s) and any other information which you provide during our

No third-party providers have access to your data, unless specifically required by law.
